## DATA

We will treat the following data:

**Recording data** - When you register, we collect the following personal data: name, surname, address, telephone number, email address, password, social security number, etc .; both you in conjunction with the minor / incompetent who possibly represents.

**Your profile data** - When you add new data to your Profile, or modify existing ones, we acquire the associated personal data (UserId, time, what).

**Navigation data** - When you connect to our system, it automatically records information that your computer sends us. This information may relate to the uploaded content, concluded transactions, the operations carried out, the IP address and MAC Address from which request the services, the date and time of your request, etc.

**Cookies** - When you use our services are only used session cookies (small text files containing a string of alphanumeric characters) that are deleted after you close your browser.

**Communications** - When you send us an email or another communication we record the communication itself.

## PURPOSE

The data will be processed for the following purposes:

- protect the technical functioning of our computer system;
- protect the confidentiality of the data provided to us;

registration, if you deny your consent we will not give you over; you can contact us at any time to ask us to stop it).

## MODE

Your data will be:

- collected electronically;
- recorded in digital form on a server in our readiness;
- protected from risk of destruction, modification, deletion or unauthorized access through efficient from physical security, logical security and organizational security;
- possibly further processed, including hardcopy, to the extent and in the time strictly necessary to implement the above purposes.

## COMMUNICATION TO THIRD PARTIES

We may disclose such data to third parties who work with us and shall treat process steps necessary for the proper performance of our activities, exclusively for the purposes indicated above.

We will also:

- communicate and spread your information, but only in anonymous and aggregate form, to disseminate information on the use of our services;
- share your information to third parties to comply with legal obligations or to comply with orders from public authorities, including the judicial authorities, to reply to allegations according to which the data that you upload using our services violates the rights of third parties, or to protect our rights or third parties in accordance with law and / or in accordance with the conditions of service.

## NATURE AND EFFECTS OF ASSIGNMENT
